The data reported to ODIHR do not present cases of hate crime and hate speech separately. Hate crime data are collected by the Provincial Agencies for State Protection and Counter Terrorism and the Federal Agency for State Protection and Counter Terrorism (BVT) of the Interior Ministry, as well as by the Ministry of Justice. Hate crime data are regularly published (Verfassungsschutzberichte)
